Call to Order: Meeting called to order at 1803 Hours by Gerry Hough.

President's Statement: Gerry thanked everyone that has help make the airport what it is today.

Hearing of Non-Board Members:

Secretary's Report:

Minutes of the 5 November 2023 Board of Directors meetings were presented. Roger Doran made a motion to approve the minutes. 2nd by Gary Morris. Motion passed.

Treasurer's Report:

Roger Doran presented the Treasurer's Report. Motion to approve made by Gary Morris. 2nd by Jon Bargren. Motion passed.

Old Business:

TJ Graden reported that the new internet service has been installed – all is good with it.

New Windsock – TJ Graden reported that he has a new windsock and he and Jon Bargren will install it.

Fuel System – TJ Graden

TJ reported that our supplier is working on getting new tanks for our fuel farm. He suggested that we pour a concrete pad if new tanks are installed.

TJ reported that the results of the quality test of the 100LL fuel are fine. 100LL is now available again.

New Business:

Gerry Hough made a motion to get the new internet service into the club house. 2nd by Jon Bargren. Motion passed. TJ Graden will call the internet service provide to arrange for internet into the club house.

Shellie Graden announced that the 2024 bathroom cleaning schedule has been posted.

Andrew Mundt suggested that OCPI check into installing a shower next to the existing bathroom in the rear of Hangar A1.

At a future date, a different type of mower, similar to a Toro 4700 should be considered. The topic was briefly discussed – no board action taken.

Gary Melvin asked if the OCPI records could be stored at C55. TJ Graden said he will look for a used fireproof file cabinet, safe, or similar. It was also discussed how long we are required to keep records. The board directed Secretary Gary Melvin to contact Attorney Dan Fishburn to get his opinion.

Treasurer Roger Doran reported that the real estate assessment increased 22%. New Hangar C1 had some impact on the increase but doesn't account for the full amount of the increase.

Shellie Graden and Gary Melvin collected, copied, and mailed documents requested by a legal firm assigned to collect such for a lawsuit that involves a former member. OCPI invoiced the law firm \$242.93 for copying costs, labor, postage, and travel mileage pursuant to their request. (It is unknown whether or not OCPI will receive compensation – there was no provision for that noted in the requesting document.)

It was noted that both OCPI and RRF pay GoRochelle.com for web hosting. RRF is \$300/year; OCPI is more. It was noted that Shellie Graden manages the website content for both organizations, raising the question of cost verses benefit of contracting GoRochelle.com. TJ Graden will discuss other options with our new internet service provider.
